

Child and adolescent suicide is now the second-leading cause of death for individuals aged 10 to 25, making it a growing and alarming concern. The trend arises from a multifaceted interplay of psychological, social, and environmental stressors that contribute to suicidal ideations or actions. Understanding the causes and identifying preventive strategies are crucial to addressing these issues effectively. Addressing the rising incidents of youth suicides requires understanding its root causes, identifying risk factors, and implementing preventive measures.

Suicidal stressors tend to arise from:

- 1. Depression & Anxiety
- 2. Social Media and Cyberbullying
- 3. Academic Pressure
- 4. Isolation
- 5. Family and Relationship Issues
- 6. Substance Abuse
- 7. Access to firearms or medications
